

Healthcare M&A

U.S. Healthcare merger activity through June 30, 2017 slowed from the record levels seen in 2015 and 2016. The continued deliberation of healthcare reform in Washington has slowed activity as operators look to gain insight into a politically driven changing healthcare landscape. In the face of reform, CMS is estimating strong growth in US healthcare spending at an average of 5.6% annually over the next decade under the currently constructed ACA. Further, certain services positioned well for recent changes to Medicare Access and CHIP Reauthorization Act of 2015 (MACRA) and the aging baby boomer population are expected to grow strongly over the next decade. For instance, CMS is projecting over 6.7% growth in home health services over the next decade.

The fate of the ACA is still uncertain; however, we are finding operators continue to acquire and form strategic partnerships with leading providers and services. Groups driving high margin ancillary service lines continue to search for acquisitions with large patient bases in their service area and complementary models in contiguous and reimbursement friendly territories. Furthermore, operators continue to make sound investments in technology to gain insights into performance improvement and improve cost and quality measures. Healthcare providers that have not invested in technology look to M&A to compete with peers that have built out data capabilities. Healthcare providers are able to leverage this infrastructure to improve managed care contracting and collections and better identify cost savings and growth initiatives.

On the provider front, behavioral health care and physician medical groups continue to show strong gains in deal activity in 2017. Mazzone & Associates continues to see strong interest in multi-location specialty physician group models from private equity groups and has seen increased appetite and activity in dermatology, gastroenterology, ophthalmology, and other specialty groups. For healthcare products and services, acquisition activity in 2017 has remained strong for high growth sectors, including biotechnology, healthcare technology, and healthcare services. Emergency medicine and telemedicine has remained very active and competitive as we continue to see spin-offs of large hospital networks and roll-up/roll-out cost-effective models and strategies as operators build nationwide platforms.

Mazzone & Associates continues to remain active in 2017 representing both sellers and buyers of healthcare providers, healthcare services, and healthcare technology clients. 
Healthcare M&A / continued

Transaction Activity / # of deals completed

Transaction activity for the Trailing Twelve Month (TTM) period ending June 30, 2017 was down by 12% compared to the same period in 2016. With a strong Q1 and Q2 in 2016, we saw a slight decrease in deal activity later in the year, which was driven by a lack of clear direction from either U.S. Presidential candidate and the current administration. With an ever complex and stringent regulatory environment, M&A has seen many institutional and strategic groups show strong interest in partnering with quality providers, brands, established platforms, and underperforming assets where the buyers have strong operating expertise and infrastructure to leverage. Over the first half of 2017, strategic buyers remained active and represented over 85% of all reported healthcare acquisitions, which was consistent with activity in 2015 and 2016. Managed healthcare and healthcare facilities have seen the largest drop off of the ten industry groups that compose this report.

Transaction Value / \$-value of deals completed

The healthcare market completed \$203 billion of transactions for the TTM period ending June 20, 2017 – a 16% decrease from 2016. Private funds that hit the road in 2016 found healthy appetites among investors, with more than \$500 billion raised each year since 2013, it has been a banner period, with capital pouring into every private capital asset class. The 20% decrease of large corporate transactions of over \$1 billion drove this figure downward. Healthcare equipment, healthcare suppliers, and healthcare services have shown the strongest growth in transaction value in 2017.



Valuations

With relatively inexpensive and easy access to capital, industry players faced with modest organic growth scenarios are creating shareholder value by deploying capital for inorganic M&A transactions. Enterprise value (EV) to EBITDA multiples increased for five of eight industries reported over the first half of 2017. The average EV/EBITDA multiple of completed healthcare transactions for the TTM period ending June 2017 was 13.9x EBITDA. Given that credit availability affects valuations so heavily, we have seen increasing valuations and flexible structures for quality companies sold through competitive investment banking processes over the last few years. With increasing operating costs and low price increases, EV/Revenue valuation multiples slightly declined to 2.0x EV/Revenue for the TTM period ending June 30, 2017.

Summary


We continue to see strong interest in consolidations in providers with value based approaches to healthcare and differentiated specialty models, and highly scalable healthcare services and cost saving solutions. This has driven increased appetite for profitable captivated healthcare delivery models as well as patient population management. In turn, valuations of healthcare companies remain at record highs. Recent influx of institutional capital and proven healthcare-focused investor groups has driven an increase in Middle Market private equity interest and focus on healthcare, as well as capital options from investment groups. It is becoming increasingly fashionable for private equity groups to differentiate themselves, by providing debt capital and non-control equity options vs. the traditional buyout option as they look to partner with strong management teams.

We continue to see regulatory issues looming as potential drivers to further M&A activity, including state law restrictions on corporate practice of medicine and restrictions on referrals under the Stark Act and anti-kickback statutes. Investors that are able to quantify and address these risks will be well-suited to capture the next wave in consolidations. 




Transaction Activity by Sub-Industry

Figure 3A **Biotechnology Activity** \$90,000 \$76,623 \$70,497






Healthcare Equipment Activity Figure 3D



Healthcare Facilities Activity Figure 3E





